

The following reports the results of every Special and General Court-Martial tried within the United States Navy in August 2023. The cases are separated by the Navy Region in which they were convened. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Naval District Washington

General Court-Martial

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, Virginia, LS2 Eric Babbitt, USN, pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery upon a child, one specification of attempted sexual abuse of a child involving indecent exposure, and one specification of sexual abuse of a child involving indecent conduct. On 1 August 2023, consistent with the plea agreement, the military judge sentenced him to total forfeitures, 13 years confinement, a reduction in paygrade to E-1, and a Dishonorable Discharge.
- At a General Court-Martial in Norfolk, Virginia, LT Jackus Allen, USN, pled guilty pursuant to a plea agreement to one specification of obstruction of justice and one specification of conduct unbecoming an officer. On 11 August 2023, consistent with the plea agreement, the military judge sentenced him to six months confinement. The plea agreement contained a waiver of the accused's administrative separation board.
- At a General Court-Martial in Norfolk, Virginia, an E-6, USN, was tried for two specifications of sexual assault and one specification of abusive sexual contact. On 24 August 2023, a panel of members returned a verdict of not guilty.
- At a General Court-Martial in Norfolk, Virginia, an E-6, USN, was tried for one specification of sexual assault, one specification of abusive sexual contact, and one specification of false official statement. On 24 August 2023, a panel of members returned a verdict of not guilty.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, EMFA Cristopher Delgadillo, USN, pled guilty pursuant to a plea agreement to one specification of unauthorized absence and one specification of a violation of a lawful general order. On 2 August 2023, consistent with the plea agreement, the military judge sentenced him to 50 days confinement and a Bad Conduct Discharge.
- At a Special Court-Martial in Norfolk, Virginia, PSC Damien Baisden, USN, pled guilty pursuant to a plea agreement to three specifications of wrongful use of a controlled substance. On 16 August 2023, consistent with the plea agreement, the military judge sentenced him to 142 days confinement. The plea agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in Jacksonville, Florida, HM3 Pedro Henrique Pereira Da Silva, USN, pled guilty pursuant to a plea agreement to one specification of larceny of non-military property. On 2 August 2023, consistent with the plea agreement, the military judge sentenced him to 45 days confinement and a reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Mayport, Florida, an E-2, USN, was tried for one specification of assault consummated by a battery. On 15 August 2023, the military judge returned a verdict of not guilty.
- At a Special Court-Martial in Mayport, Florida, EM2 Christopher Cheeks, USN, pled guilty pursuant to a plea agreement to one specification of larceny of military property. On 17 August 2023, consistent with the plea agreement, the military judge sentenced him to 60 days confinement and a reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Pensacola, Florida, AWW3 Ricky Beltran, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence involving a violent offense. On 23 August 2023, consistent with the plea agreement, the military judge sentenced him to 30 days confinement, a reduction in paygrade to E-3, and a Bad Conduct Discharge.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in San Diego, California, ABH3 Davionne Jackson, USN, pled guilty pursuant to a plea agreement to one specification of fraudulent enlistment, one specification of obstruction of justice, and one specification of insubordinate conduct and disrespect toward a petty officer. On 15 August 2023, consistent with the plea agreement, the military judge sentenced him to nine months confinement, a reduction in paygrade to E-3, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, MT3 Alec Holstine, USN, pled guilty pursuant to a plea agreement to one specification of indecent recording. On 21 August 2023, consistent with the plea agreement, the military judge sentenced him to six months confinement and a Bad Conduct Discharge.
- At a Special Court-Martial in Whidbey Island, Washington, AOAA Evan Willoughby, USN, pled guilty pursuant to a plea agreement to one specification of conspiracy to wrongfully possess a controlled substance and one specification of disrespect toward a petty officer. On 23 August 2023, consistent with the plea agreement, the military judge sentenced him to 31 days confinement and a reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Whidbey Island, Washington, ADAN Michael Garrido, USN, pled guilty pursuant to a plea agreement to one specification of wrongful use of a controlled substance, one specification of wrongful possession of a controlled substance, and two specifications of wrongful use of marijuana,. On 24 August 2023, consistent with the plea agreement, the military judge sentenced him to 28 days confinement, a reduction in paygrade to E-1, and a Bad Conduct Discharge.
- At a Special Court-Martial in Whidbey Island, Washington, AM2 Jakob Abney, USN, pled guilty pursuant to a plea agreement to one specification of wrongful use of a controlled substance. On 25 August 2023, consistent with the plea agreement, the military judge sentenced him to 15 days confinement and a reduction in paygrade to E-1.

On 23 August 2023, consistent with the plea agreement, the military judge sentenced him to eight months confinement and a Bad Conduct Discharge.

On 29 August 2023, consistent with the plea agreement, the military judge sentenced to him three years confinement, a reduction in paygrade to E-1, and Dishonorable Discharge.
