

The following reports the results of every Special and General Court-Martial tried within the United States Navy in March 2024. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, OS2 Taylor Spradlin, USN, pled guilty pursuant to a plea agreement to four specifications of violating a lawful general order. On 20 March 2024, consistent with the plea agreement, the military judge sentenced him to a reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Norfolk, Virginia, OS1 Rolando Carr, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence involving a violent offense and one specification of willfully disobeying a superior commissioned officer. On 29 March 2024, consistent with the plea agreement, the military judge sentenced him to 84 days confinement, a reduction in paygrade to E-3, and a Bad Conduct Discharge.

- At a General Court-Martial in Mayport, Florida, OS2 Riley Coleman, USN, was tried for one specification of abusive sexual contact, one specification of assault consummated by a battery, one specification of assault consummated by a battery upon a person in the execution of law enforcement duties, and one specification of wrongful use of a controlled substance. On 1 March 2024, a panel of members returned a verdict of guilty

to one specification of abusive sexual contact, one specification of assault consummated by a battery, and one specification of wrongful use of a controlled substance and sentenced him to forfeitures of pay for \$2,017 for 4 months, 120 days confinement, a reduction in paygrade to E-1, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in San Diego, California, an E-4, USN, was tried for two specifications of assault consummated by a battery and one specification of assault with the intent to commit kidnapping. On 8 March 2024, a panel of members found the accused not guilty.
- At a Special Court-Martial in San Diego, California, CMDCS Grisel Marrero, USN, pled guilty to two specifications of willful dereliction of duty, two specifications of false official statement, and not guilty to one specification of obstruction of justice. On 8 March 2024, a panel of members returned a verdict of guilty to the one specification of obstruction of justice. The military judge sentenced her to a reduction in paygrade to E-7.
- At a Special Court-Martial in San Diego, California, QM1 Alexander Love, USN, pled guilty pursuant to a plea agreement to one specification of violating a lawful general order. On 14 March 2024, consistent with the plea agreement, the military judge sentenced him to a reduction in paygrade to E-5.

- At a General Court-Martial in Kaiserslautern, Germany, RS2 Tavian Douglas-Rogan, USN, was tried for one specification of attempted rape, one specification of attempted sexual assault, one specification of abusive sexual contact, one specification of assault with the intent to commit rape, one specification of burglary with the intent to commit sexual assault, and one specification of misappropriation of property. On 1 March 2024, a panel of members found the accused guilty of all charges and specifications, and sentenced him to 39 months confinement, a reduction in paygrade to E-1, and a Dishonorable Discharge.
