

The following reports the results of every Special and General Court-Martial tried within the United States Navy in September 2024. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, SN Brandon Michel, USN, pled guilty pursuant to a plea agreement to two specifications of assault consummated by a battery. On 6 September 2024, consistent with the plea agreement, the military judge sentenced him to 120 days confinement and reduction in paygrade to E-2. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Norfolk, Virginia, DCFN Devin Broadus, USN, pled guilty pursuant to a plea agreement to one specification of conspiracy, one specification of false official statement, and one specification of destruction of military property. On 26 September 2024, consistent with the plea agreement, the military judge sentenced him to forfeitures of \$1344 a month for six months, 120 days confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.
- At a Special Court-Martial in Great Lakes, Illinois, SA Justin Montgomery, USN, pled guilty pursuant to a plea agreement to three specifications of abusive sexual contact. On 26 September 2024, consistent with the plea agreement, the military judge sentenced him to five months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.
- At a Special Court-Martial in Norfolk, Virginia, AO3 Jordan Goodson, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence involving the

commission of a violent offense, one specification of willfully disobeying a superior commissioned officer, and one specification of possession of a controlled substance. On 27 September 2024, consistent with the plea agreement, the military judge sentenced him to 60 days confinement and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Southeast

Special Court-Martial

- At a Special Court-Martial in Mayport, Florida, EO1 Tyler Brown, USN, pled guilty pursuant to a plea agreement to one specification of child endangerment. On 5 September 2024, consistent with the plea agreement, the military judge sentenced him to no punishment.
- At a Special Court Martial in Jacksonville, Florida, AN Braxton Stultz, USNR, pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery. On 12 September 2024, consistent with the plea agreement, the military judge sentenced him to 37 days confinement and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court Martial in Pensacola, Florida, ABEAA Tylique Franklin-Fasoranti, USN, pled guilty pursuant to a plea agreement to one specification of aggravated assault with the infliction of substantial bodily harm. On 27 September 2024, consistent with the plea agreement, the military judge sentenced him to forfeitures of \$1,000 a month for six months, reduction in paygrade to E-1, and to be restricted to the limits of Naval Air Station Pensacola for 60 days. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, an E-5, USN, was tried for six specifications of abusive sexual contact. On 12 September 2024, the panel of members found the accused not guilty of all specifications.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, ETN3 Tanner Davis, USN, pled guilty pursuant to a plea agreement of one specification of being drunk and disorderly. On 18 September 2024, consistent with the plea agreement, the military judge sentenced

him to 30 days confinement and reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, NC1 David Ifill, USN, pled guilty pursuant to a plea agreement to one specification of indecent conduct and two specifications of assault consummated by a battery. On 12 September 2024, consistent with the plea agreement, the military judge sentenced him to 6 months confinement and reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.

Special Court-Martial

- At a Special Court-Martial in San Diego, California, ADSC Nathan Babauta, USN, pled guilty pursuant to a plea agreement to one specification of violation of a lawful general order and one specification of extramarital sexual conduct. On 5 September 2024, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-6.
- At a Special Court-Martial in San Diego, California, AS2 Doland Miller III, USN, pled guilty pursuant to a plea agreement to one specification of attempted indecent language communicated to a child under the age of 16. On 6 September 2024, consistent with the plea agreement, the military judge sentenced him to one year confinement and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in San Diego, California, SA Antonio Jones, USN, pled guilty pursuant to a plea agreement to two specifications of willfully disobeying a superior commissioned officer and one specification of communicating a threat. On 17 September 2024, consistent with the plea agreement, the military judge sentenced him to 48 days confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.
