

The following reports the results of every Special and General Court-Martial tried within the United States Navy in February 2025. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Naval District Washington

General Court-Martial

Special Court-Martial

- At a Special Court-Martial in Washington, DC, HMC Marc Perkins, USN, pled guilty pursuant to a plea agreement to one specification of making a false official statement and one specification of larceny. On 26 Feb 2025, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-6. The plea agreement contained a waiver of the accused's administrative discharge board.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Jacksonville, FL, CSS1 Colton Blevins, USN, was tried for three specifications of sexual abuse of a child, two specifications of indecent conduct, one specification of producing child pornography, three specifications of possessing child pornography, one specification of viewing child pornography, two specifications of receiving child pornography, and three specifications of obstructing justice. On 4 February 2025, a panel of members returned a verdict of guilty to three specifications of sexual abuse of a child, one specification of indecent conduct, one specification of producing child pornography, three specifications of possessing child pornography, one specification of viewing child pornography, two specifications of receiving child pornography, and three specifications of obstructing justice. On 4 February 2025, a panel

of members sentenced him to reprimand, 10 years confinement, reduction in paygrade to E-3, and a Dishonorable Discharge.

- At a General Court-Martial in Jacksonville, FL, EMN3 Sage Treadwell, USN, pled guilty pursuant to a plea agreement to one specification of possessing child pornography and one specification of distributing child pornography. On 20 February 2025, consistent with the plea agreement, the military judge sentenced him to 4 years confinement, reduction in paygrade to E-1, and a Dishonorable Discharge.
- At a General Court-Martial in Jacksonville, FL, OS2 Raul Paneto, USN, was tried for five specifications of domestic violence – commission of a violent offense, two specifications of domestic violence against property with intent to threaten or intimidate, two specifications of domestic violence with intent to threaten or intimidate, and one specification of violating a protection order with intent to threaten or intimidate. On 28 February 2025, a panel of members returned a verdict of guilty to one specification of domestic violence with intent to threaten or intimidate and one specification of communicating a threat, a lesser included offense under domestic violence with intent to threaten or intimidate. On 28 February 2025, a panel of members sentenced him to no punishment.

Special Court-Martial

- At a Special Court-Martial in Pensacola, FL, AN Tanner Vogelsang, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence – commission of a violent offense. On 24 February 2025, consistent with the plea agreement, the military judge sentenced him to forfeitures of two-thirds month's pay for 6 months and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Northwest

- At a General Court-Martial in Bremerton, WA, an E-7 was tried for one specification of indecent exposure and one specification of sexual assault. On 28 February 2025, a panel of members found the accused not guilty.

Special Court-Martial

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, CA, AO2 Jose Velazquez Vazquez, USN, pled guilty pursuant to a plea agreement to one specification of indecent conduct, and one specification of making a false official statement. On 12 February 2025, consistent with the plea agreement, the military judge sentenced him to 18 months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Pearl Harbor, Hawaii, QM2 Mitchell Faircloth, USN, pled guilty pursuant to a plea agreement to one specification of dishonorably failing to pay a debt, one specification of larceny of a non-military vehicle, one specification of making a false official statement, and one specification of making a forgery. On 18 February 2025, consistent with the plea agreement, the military judge sentenced him to forfeitures of \$1405 a month for 4 months, 4 months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.

Navy Region Japan

General Court-Martial

- At a General Court-Martial in Yokosuka, Japan, CS2 Patrick Charles, USN was tried for three specifications of sexual assault and one specification of making a false official statement. On 1 February 2025, a panel of members returned a verdict of guilty to one specification of making a false official statement. On 1 February 2025, the military judge sentenced him to reduction in paygrade to E-4.

Special Court-Martial

- At a Special Court-Martial in Naples, Italy, EN1 Fernando Gonzales, USN, pled guilty pursuant to a plea agreement to two specifications of assault consummated by a battery and one specification of violating a lawful general order. On 26 February 2025, consistent with the plea agreement, the military judge sentenced him to 31 days confinement and reduction in paygrade to E-4. The plea agreement contained a waiver of the accused's administrative discharge board.
