

The following reports the results of every Special and General Court-Martial tried within the United States Navy in June 2025. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Naval District Washington

General Court-Martial

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, VA, MM2 Christopher Emro, USN, pled guilty pursuant to a plea agreement to one specification of attempted sexual abuse of a child. On 12 June 2025, consistent with the plea agreement, the military judge sentenced him to 15 months confinement and a Bad Conduct Discharge.
- At a General Court-Martial in Great Lakes, IL, FA Anthony Archuleta, USN, pled guilty pursuant to a plea agreement to one specification of failing to obey a lawful general order, one specification of failing to obey a lawful written order, and one specification of obstructing justice. On 17 June 2025, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1 and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Norfolk, VA, AOAN Amara Kandeh, USN, pled guilty pursuant to a plea agreement to four specifications of knowingly using a stolen credit or debit card to obtain property of a value of \$1000 or less and two specifications of attempted fraudulent use of a debit card. On 10 June 2025, consistent with the plea agreement, the military judge sentenced him to forfeitures of \$500 per month for 3 months and 3 months confinement. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a Special Court-Martial in Great Lakes, IL, an E-8 was tried for one specification of an attempt to effect an unlawful enlistment and one specification of conspiracy to effect

an unlawful enlistment. On 12 June 2025, a panel of members found the accused not guilty to all charges and specifications.

- At a Special Court-Martial in Norfolk, VA, MAC Cornelius Johnson, USN, was tried for six specifications of violating a lawful general order and one specification of sexual harassment. On 13 June 2025, a panel of members returned a verdict of guilty to one specification of violating a lawful general order and the military judge sentenced him to reduction in paygrade to E-6.
- At a Special Court-Martial in Norfolk, VA, EM2 Michael Wucher, USN, pled guilty pursuant to a plea agreement to one specification of conspiracy to commit larceny, one specification of larceny of military property of a value of approximately \$14,600, and one specification of larceny of military property of a value of \$1,000 or less. On 26 June 2025, consistent with the plea agreement, the military judge sentenced him to 3 months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Jacksonville, FL, HM3 Yuan Li pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery and one specification of making a fraudulent claim. On 25 June 2025, consistent with the plea agreement, the military judge sentenced him to 10 months confinement. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a General Court-Martial in Jacksonville, FL, HM2 Phillip Murillo, USN, pled guilty pursuant to a plea agreement to one specification of indecent conduct. On 26 June 2025, consistent with the plea agreement, the military judge sentenced him to 225 days confinement. The plea agreement contained a waiver of the accused's administrative discharge board.

- At a Special Court-Martial in Bremerton, WA, MM2 Ivory Casey, USN, pled guilty pursuant to a plea agreement to one specification of larceny of more than \$20,000 of government funds. On 6 June 2025, consistent with the plea agreement, the military judge sentenced him to \$1,500 in fines and reduction in paygrade to E-3. The plea agreement contained a waiver of the accused administrative discharge board.

- At a Special Court-Martial in San Diego, CA, ABHAN Adan Lopez, USN, pled guilty pursuant to a plea agreement to one specification of unlawful entry. On 2 June 2025, consistent with the plea agreement, the military judge sentenced him to 3 months confinement and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a Special Court-Martial in San Diego, CA, BMC Michael Bell, USN, pled guilty pursuant to a plea agreement to two specifications of conspiracy to commit wire fraud. On 12 June 2025, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-6. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a Special Court-Martial in Lemoore, CA, LSCS Elliott Jones, USN pled guilty pursuant to a plea agreement to sixteen specifications of larceny of non-military property of a value of \$1,000 or less. On 17 June 2025, consistent with the plea agreement, the military judge sentenced him to 60 days restriction to Naval Air Station Lemoore and reduction in paygrade to E-6.
- At a Special Court-Martial in San Diego, CA, LS3 Tariq Dundas, USN, pled guilty pursuant to a plea agreement to two specifications of wrongful use of a controlled substance. On 23 June 2025, consistent with the plea agreement, the military judge sentenced him to 120 days confinement and reduction in paygrade to E-1.

- At a General Court-Martial in Norfolk, VA, IT2 Moshe Brown, USN, pled guilty pursuant to a plea agreement to three specifications of possessing child pornography and one specification of obstructing justice. On 3 June 2025, consistent with the plea agreement, the military judge sentenced him to total forfeitures, 24 months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.
