

The following reports the results of every Special and General Court-Martial tried within the United States Navy in July 2025. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.

Special Court-Martial

- At a Special Court-Martial in Great Lakes, IL, FCSA Ashton Funk-Thompson, USN, pled guilty pursuant to a plea agreement to one specification of wrongful distribution of a controlled substance. On 24 July 2025, consistent with the plea agreement, the military judge sentenced him to 180 days confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Jacksonville, FL, CS3 Elida Ibarra Ramirez, USN, was tried for one specification of making a false official statement. On 17 July 2025, a panel of members returned a verdict of guilty and sentenced her to forfeitures of \$1,999 per month for 5 months, 150 days confinement, and reduction in paygrade to E-2.

- At a Special Court-Martial in Jacksonville, FL, AZ2 Lovric Nilooban, USN, pled guilty pursuant to a plea agreement to one specification of possessing child pornography. On 22 Jul 2025, consistent with the plea agreement, the military judge sentenced him to 8 months confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Whidbey Island, WA, AM2 Leonardo Olmos, USN, pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery. On 2 July 2025, consistent with the plea agreement, the military judge sentenced him to 90 days confinement. The plea agreement contained a waiver of the accused's administrative discharge board.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, CA, AOC Nicholas Robledo, USN, pled guilty pursuant to a plea agreement to one specification of conspiracy to commit indecent recording, one specification of distributing indecent visual recording, one specification of wrongful distribution of a controlled substance, and one specification of wrongful possession of a controlled substance. On 28 July 2025, consistent with the plea agreement, the military judge sentenced him to total forfeitures, 5 years and 7 months confinement, reduction in paygrade to E-1, and a Dishonorable Discharge.

Special Court-Martial

- At a Special Court-Martial in San Diego, CA, LS3 Ivan Poplevko, USN, pled guilty pursuant to a plea agreement to one specification of wire fraud. On 1 July 2025, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1.
- At a Special Court-Martial in San Diego, CA, ABE3 Juan Dieppa Guadalupe, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence – commission of a violent offense, and one specification of child endangerment by culpable negligence. On 15 July 2025, consistent with the plea agreement, the military judge sentenced him to 6 months confinement. The plea agreement contained a waiver of the accused's administrative discharge board.

- At a Special Court-Martial in San Diego, CA, HMC Christopher Morgan, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence – commission of a violent offense, and one specification of willfully disobeying a superior commissioned officer. On 18 July 2025, consistent with the plea agreement, the military judge sentenced him to 30 days confinement and reduction in paygrade to E-6.
- At a Special Court-Martial in San Diego, CA, ABFAN Zaire Childs, USN, pled guilty pursuant to a plea agreement to one specification of fraudulent use of an access device to obtain money of a value of more than \$1,000. On 30 July 2025, consistent with the plea agreement, the military judge sentenced him to 100 days confinement and reduction in paygrade to E-1.
