

**The following reports the results of every Special and General Court-Martial tried within the United States Navy in August 2025. The cases are separated by the Navy Region in which they were tried. Reference to the inclusion of a waiver of an administrative separation board in the plea agreement will only be reported in those cases where a punitive discharge is not adjudged as part of the sentence.**

## **Naval District Washington**

### **General Court-Martial**

## **Navy Region Mid-Atlantic**

### **General Court-Martial**

- At a General Court-Martial in Norfolk, VA, EMN3 Noah Weber, USN, pled guilty pursuant to a plea agreement to one specification of possessing child pornography, one specification of indecent language related to child pornography, and one specification of receiving child pornography. On 7 August 2025, consistent with the plea agreement, the military judge sentenced him to 42 months confinement, reduction in paygrade to E-1, and a Dishonorable Discharge.
- At a General Court-Martial in Norfolk, VA, AO1 Major Kenny, USN, pled guilty pursuant to a plea agreement to one specification of domestic violence – commission of a violent offense. On 21 August 2025, consistent with the plea agreement, the military judge sentenced him to no punishment. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a General Court-Martial in Great Lakes, IL, GSE3 Roman Navarro, USN, pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery. On 21 August 2025, consistent with the plea agreement, the military judge sentenced him to 6 months confinement, reduction in paygrade to E-3, and a Bad Conduct Discharge.
- At a General Court-Martial in Norfolk, VA, AOAN Nevin Day, USN, pled guilty pursuant to a plea agreement to two specifications of domestic violence – commission of a violent offense, one specification of domestic violence, and three specifications of failing to obey a lawful general order. On 28 August 2025, consistent with the plea agreement, the military judge sentenced him to 1 year and 6 months confinement and a Bad Conduct Discharge.

### **Special Court-Martial**

- At a Special Court-Martial in Norfolk, VA, AT2 Bradley Komes, USN, pled guilty pursuant to a plea agreement to one specification of child endangerment by culpable negligence. On 5 August 2025, consistent with the plea agreement, the military judge sentenced him to no punishment.

## **Navy Region Southeast**

### **General Court-Martial**

- At a General Court-Martial in Mayport, FL, AM2 Neal Scott, USN, was tried for five specifications of domestic violence – commission of a violent offense and one specification of child endangerment by culpable negligence resulting in harm. On 25 August 2025, a panel of members returned a verdict of guilty to one specification of domestic violence – commission of a violent offense and one specification of child endangerment by culpable negligence resulting in harm. On 25 August 2025, the panel of members sentenced him to 3 months hard labor, 2 months restriction, and reduction in paygrade to E-3.

### **Special Court-Martial**

- At a Special Court-Martial in Jacksonville, FL, OS2 Timothy Maloney, USN, pled guilty pursuant to a plea agreement to two specifications of domestic violence – commission of a violent offense. On 6 August 2025, consistent with the plea agreement, the military judge sentenced him to no punishment. The plea agreement contained a waiver of the accused's administrative discharge board.

## **Navy Region Northwest**

### **General Court-Martial**

- At a General Court-Martial in Bremerton, WA, LCpl Jonathan Huffman, USMC, pled guilty pursuant to a plea agreement to one specification of assault upon a military law enforcement officer. On 14 August 2025, consistent with the plea agreement, the military judge sentenced him to 119 days confinement, reduction in paygrade to E-1, and a Bad Conduct Discharge.
- At a General Court-Martial in Bremerton, WA, IT3 Jerrhon Mosley, USN, pled guilty pursuant to a plea agreement to one specification of abusive sexual contact. On 18 August 2025, consistent with the plea agreement, the military judge sentenced him to 13 months confinement, reduction in paygrade to E-3 and a Bad Conduct Discharge.

## **Special Court-Martial**

- At a Special Court-Martial in Bremerton, WA, MMN1 Adam Marston, USN, was tried for one specification of abusive sexual contact, four specifications of assault consummated by a battery, and one specification of sexual harassment. On 7 August 2025, a panel of members returned a verdict of guilty to two specifications of assault consummated by a battery and one specification of sexual harassment. On 7 August 2025, a panel of members sentenced him to reduction in paygrade to E-4 and a Bad Conduct Discharge.
- At a Special Court-Martial in Bremerton, WA, BMC Lazarus Bullock, USN, pled guilty pursuant to a plea agreement to one specification of larceny. On 29 August 2025, consistent with the plea agreement, the military judge sentenced him to a fine of \$46,000.

- At a Special Court-Martial in San Diego, CA, LSCM Frances Estrada, USN, pled guilty pursuant to a plea agreement to one specification of conspiracy to commit wire fraud. On 6 August 2025, consistent with the plea agreement, the military judge sentenced her to reduction in paygrade to E-8. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a Special Court-Martial in San Diego, CA, CWO3 Aaron Crawford, USN pled guilty pursuant to a plea agreement to two specifications of unauthorized absence and one specification of violating a lawful general order. On 15 August 2025, consistent with the plea agreement, the military judge sentenced him to 60 days confinement. The plea agreement contained a waiver of the accused's administrative discharge board.
- At a Special Court-Martial in San Diego, CA, EN3 Ryan Decker, USN, was tried for one specification of desertion, two specifications of disrespect toward a superior petty officer, and one specification of disrespect toward a superior commissioned officer. On 8 August 2025, a panel of members returned a verdict of guilty to all charges and specifications and the military judge sentenced him to reduction in paygrade to E-2.
