## **Registration and Enrollment**

# Advanced Environmental Law

Washington, D.C. 7-8 Feb 2024

**Course Description**—This course provides senior environmental law practitioners with a graduate-level update on federal and state environmental laws and regulations, as well as information on DoD policy and procedures to ensure compliance. It allows an exchange of views on environmental compliance strategies with sister service practitioners and senior environmental advisors. It is designed for attorneys with regional, major command, or service-wide environmental legal responsibilities

**Prerequisites**—None

**Target Audience**— Senior environmental law practitioners.



# Advanced Labor & Employment Law

## Washington, D.C. 13-17 May 2024

**Course Description**— This course provides judge advocates, civilian attorneys, and personnel engaged in advising and representing Air Force management on labor and personnel law with advanced instruction on the latest principles and concepts of civilian personnel management, litigation trends, and policy initiatives. The curriculum focuses on providing advanced information on substantive federal civilian employment law, litigation issues before the Merit Systems Protection Board, equal employment opportunity in the federal government, federal-sector labor management relations, ethics, and other miscellaneous federal sector issues. There is particular emphasis on issues unique to the military environment. The course features distinguished guest speakers from various agencies of the Federal Government

**Prerequisites**—None

**Target Audience**— Individuals needing advanced knowledge in Labor and Employment Law.



## Cyber Law Course

Maxwell Air Force Base, AL , 22-26 Jan 2024

**Course Description**—The Cyber Law Basic Course is a survey course aimed at introducing DoD legal professionals with no training or experience in cyberspace operations to the cyberspace domain, DoD operations in cyberspace, and the domestic and international rules that govern those operations. The course will start with coverage of computer, internet, and network operations, progress to lessons on DoD offensive, defensive, and intelligence-related cyberspace missions, and culminate in discussions concerning cyber-specific domestic and international rules applicable to armed conflict, intelligence gathering, and law enforcement activities.

**Prerequisites**—All attendees must have at least a SECRET security clearance, which must be verified prior to the beginning of the course.

**Target Audience**— Individuals with little to no experience in Cyber Law.



# Environmental Law Course

Maxwell Air Force Base, AL , 22-26 Jul 2024

**Course Description**—This course provides attorneys having primary responsibility for addressing and resolving environmental law issues with an ability to comprehend and analyze basic principles and concepts of federal environmental law. It covers major federal environmental statutes, regulations, case law, federal policy, and the environmental impact process to help ensure compliance at DoD facilities.

**Prerequisites**—None

**Target Audience**— Individuals with little to no experience in Environmental Law.



# Federal Employee Labor Law Course

Maxwell Air Force Base, AL 16-20 OCT 2023

**Course Description**—This course provides attorneys, paralegals, personalists, and EO professionals an understanding of the principles and concepts of civilian personnel law. The curriculum is focused on the role of the base-level advisor and is aimed at practical applications. The course addresses federal-sector labor management relations, employment discrimination, employee discipline and performance management, and other issues such as alternative dispute resolution, reductions-in-force, unemployment compensation, civilian drug testing, and the Fair Labor Standards Act.

**Prerequisites**—None

**Target Audience**— Individuals with little to no experience in Federal Labor Law.





## **Homeland Security / Homeland Defense**

Maxwell Air Force Base, AL 14-17 Nov 2024

**Course Description**—The Homeland Security/Homeland Defense Course provides instruction to Air Force active duty, guard and reserve component judge advocates, paralegals, and other personnel involved in the field on the complex legal problems encountered during homeland defense / homeland security missions. It prepares students to manage a myriad of different legal issues that may be encountered; general areas include homeland defense legal issues (especially air defense), defense support to civilian law enforcement authorities, the Posse Comitatus Act, the status of ANG personnel, and response to natural disasters.

**Prerequisites**—None

**Target Audience**— Individuals dealing with homeland security and defense matters in their current or future billet.



# Operations Law Course

Maxwell Air Force Base, AL 23 Oct—3 Nov 2023

**Course Description**—The Operations Law Course provides judge advocates and paralegals with an introduction to the fundamentals of operations and international law. The course trains students to identify and analyze legal and political implications of military operations. The course also teaches students to apply legal principles to operational problems and prepares students to function in support of military operations CONUS and OCONUS. Some of the topics covered during lecture and seminar instruction include: sources of international law; legal bases for the use of force; the law of armed conflict; rules of engagement; command and control; the organization and primary roles of an air operation center; air, space and cyberspace law; international agreements; foreign criminal jurisdiction; deployed fiscal law; contingency contracting; domestic operations; and Air Force legal readiness.

**Prerequisites**—None

**Target Audience**— Judge advocates and paralegals who require an introduction to the fundamentals of operations and international law.
