Bowman, U.S. Marine Corps, did, at or near Norfolk, Virginia, on or about 17 January 2024, in writing communicate to [REDACTED] a minor and family member, certain indecent language, to wit: "Ik no head," "I can't get my dick sucked," "I might beat off," "just horny and nothing to do about it," and "I lost my virginity when I was [REDACTED] hid it from my mom forever," or words to that effect, and that such conduct was of a nature to bring discredit upon the armed forces.





1. **Nature of Motion.** The parties respectfully request that the court docket the arraignment and the presentencing for 2 May 2025 and order the attached Trial Management milestones for the above captioned case.
2. **Justification.** The charges against Cpl Bowman were referred to general court-martial on 27 March 2025. The Government is attempting to serve Cpl Bowman with the referred charge sheets today (28 March 2025); however, service might be delayed until Tuesday due to a unit 96 from 28 March 2025 to 1 April 2025. The parties have entered into a plea agreement and stipulation of fact and are preparing for the presentencing proceeding. The first available date for all parties and the victim is 2 May 2025.
3. **Trial Dates and Deadlines.** The parties respectfully request that the Court docket arraignment and the presentencing proceeding for 2 May 2025.
4. **Excludable Delay.** The parties respectfully request that the court find that the period of time between the end of the statutory waiting period (post service of referred charge sheets) and the presenting proceeding (2 May 2025) be excluded. The defense specifically agrees that the delay between the end of the statutory waiting period and 2 May 2025 is attributable to the Defense and excludable under Rule for Courts-Martial 707, Article 10, UCMJ and any other applicable speedy trial authorities.
