

The following reports the results of every Special and General Court-Martial tried within the United States Navy in March 2023. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

General Court-Martial

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, Virginia, AA Janarrie Smith, USN, pled guilty pursuant to a plea agreement to one specification of sexual assault and one specification of aggravated assault with a dangerous weapon; and not guilty to a second specification of sexual assault. On 1 March 2023, the military judge accepted the guilty pleas for one specification of sexual assault and one specification of aggravated assault; and returned a verdict of not guilty to the second specification of sexual assault. Consistent with the plea agreement, the military judge sentenced him to 18 months confinement and a Dishonorable Discharge.
- At a General Court-Martial in Norfolk, Virginia, an E-3, USN, was tried for five specifications of sexual assault. On 1 March 2023, the military judge returned a verdict of not guilty to the sole charge and its specifications.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, EM3 Kymoni Black, USN, pled guilty pursuant to a plea agreement to one specification of assault consummated by a battery. On 10 March 2023, consistent with the plea agreement, the military judge sentenced him to 30 days confinement and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Norfolk, Virginia, an E-7, USN, was tried for one specification of disrespect toward a superior commissioned officer. On 22 March 2023, a panel of members returned a verdict of not guilty to the sole charge and specification.

- At a Special Court-Martial in Groton, Connecticut, ITS1 Michael Barker, USN, pled guilty pursuant to a plea agreement to one specification of indecent language. On 29 March 2023, consistent with the plea agreement, the military judge sentenced him to 30 days confinement and reduction in paygrade to E-4.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Mayport, Florida, STG3 Kyle Kirby, USN, pled guilty pursuant to a plea agreement to one specification of possession of child pornography. On 22 March 2023, consistent with the plea agreement, the military judge sentenced him to 7 months confinement, a Bad Conduct Discharge, and reduction in paygrade to E-1.
- At a General Court-Martial in Jacksonville, Florida, MASA Derrick Johnson, Jr., USN, pled guilty pursuant to a plea agreement to one specification of conspiracy to escape apprehension, one specification absence without leave, one specification of failure to obey a lawful written order, one specification of false official statement, one specification of reckless operation of a vehicle, one specification of carrying a concealed weapon, one specification of larceny, one specification of violating 18 U.S.C. § 922(g)(2) for possessing and transporting a firearm in interstate commerce while fleeing from justice, one specification of 18 U.S.C. § 2314 for transporting a stolen vehicle in interstate commerce, one specification of fleeing apprehension, and one specification of service discrediting conduct. On 29 March 2023, consistent with the plea agreement, the military judge sentenced him to 40 months confinement, a Bad Conduct Discharge, and reduction in paygrade to E-1.
- At a General Court-Martial in Mayport, Florida, ADAA Ethan Spenelli, USN, pled guilty pursuant to a plea agreement to one specification of sexual abuse of a child involving indecent communications. On 29 March 2023, consistent with the plea agreement, the military judge sentenced him to 24 months confinement, a Dishonorable Discharge, and reduction in paygrade to E-1.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, an E-5 USN, was tried for one specification of sexual assault. On 24 March 2023, the panel of members returned a verdict of not guilty on the sole charge and specification.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, LCpl Mike Nabarrette, USMC, pled guilty pursuant to a plea agreement to one specification of wrongful use of a controlled substance. On 3 March 2023, consistent with the plea agreement, the military judge sentenced him to 30 days confinement, reduction in paygrade to E-1, and forfeitures of one-half pay for one month. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Bremerton, Washington, MMN1 Devon Coby, USN, pled guilty pursuant to a plea agreement to one specification of violating a lawful general order. On 7 March 2023, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-3. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Bremerton, Washington, AOAR Antoine Perry, USN, pled guilty pursuant to a plea agreement to one specification of desertion. On 8 March 2023, consistent with the plea agreement, the military judge sentenced him to 90 days confinement, a Bad Conduct Discharge, and forfeitures of one-half pay for one month. The plea agreement contained a waiver of the accused's administration separation board.
- At a Special Court-Martial in Bremerton, Washington, LCpl Nicholas Fovos, USMC, pled guilty pursuant to a plea agreement to one specification of larceny. On 16 March 2023, consistent with the plea agreement, the military judge sentenced him to 20 days confinement, reduction in paygrade to E-1, forfeitures of two-thirds pay for one month, and a fine of \$42.37. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, AMAA Brayden Whiteman, USN, pled guilty pursuant to a plea agreement to one specification of strangulation upon a spouse, one specification of sexual abuse of a child involving indecent exposure, one specification of sexual abuse of a child involving indecent conduct, and one specification of sexual abuse of a child involving indecent communications. On 15 March 2023, consistent with the plea agreement, the military judge sentenced him to 5 years and 3 months confinement, a Dishonorable Discharge, and reduction in paygrade to E-1.

Special Court-Martial

- At a Special Court-Martial in San Diego, California, OSSN Dakota Grammer, USN, pled guilty pursuant to a plea agreement to one specification of wrongful broadcast of intimate visual images, one specification of obstruction of justice, and one specification of indecent conduct. On 8 March 2023, consistent with the plea agreement, the military

judge sentenced him to 15 days confinement. The plea agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in San Diego, California, OS2 Omar Olivarez, USN, pled guilty pursuant to a plea agreement to three specifications of assault consummated by a battery upon a child under 16 years. On 13 March 2023, consistent with the plea agreement, the military judge sentenced him to 4 months confinement. The plea agreement contained a waiver of the accused's administrative separation board.
