Subj: COMMANDER'S CRITICAL INFORMATION REQUIREMENTS FOR
COMMANDER, NAVAL LEGAL SERVICE COMMAND

1. Purpose. To establish a formal process for reporting critical information requirements.

2. Cancellation. CNLSCNOTE 3100.6

3. Background. Commander, Naval Legal Service Command (CNLSC) commander's critical information requirements (CCIRs) are significant events with the potential to impact the mission of Naval Legal Service Command (NLSC) or one of its three main elements – Region Legal Service Offices (RLSOs), Defense Service Offices (DSOs), and the Victims' Legal Counsel Program (VLCP). Timely and accurate reporting of CCIRs enables CNLSC to manage issues, shift resources, and best apprise senior Navy leadership. Reporting CCIRs under this notice will be in addition to any Situation Reports (SITREPs) or other reports required by other instructions, including references (a) through (c). SITREP copies may be forwarded to meet email notification requirements. This promulgates CNLSC's CCIRs.

4. Reporting. Enclosure (1) provides a listing of CNLSC CCIRs. CNLSC Executive Assistant (EA) is CNLSC's designated recipient for CCIR reports. Submitters should copy the NLSC Deputy Commander, NLSC Senior Enlisted Leader, NLSC Staff Judge Advocate, CNLSC Aide, and the Director, RLSO Operations, Director, DSO Operations, or Chief, VLCP as appropriate when sending e-mail reports.

5. Responsibilities

a. NLSC units will report CCIRs as outlined in enclosure (1).

b. Reports should include all relevant information known at the time of reporting and a brief summary of any intended future action. It is understood that a situation may be fluid and information may become quickly outdated. Therefore, it is up to each individual providing the report to use their best judgment and experience to determine what information is relevant to the Commander. Examples of voice and e-mail reports are contained in enclosures (2) and (3).

c. CCIRs do not require disclosure of any attorney-client privileged matters. Notifications in enclosure (1) are required by the chain of command of the affected NLSC member, but not by a DSO or VLC attorney where the attorney client-relationship would be potentially compromised by the CCIR.

6. CCIRs

a. CAT I. Those incidents which have high likelihood for imminent Secretary of the Navy (SECNAV) or Chief of Naval Operations (CNO) level interest and those with a strong likelihood to generate imminent national media attention.

(1) Timeline. Chief, VLCP or Commanding Officers (COs) will immediately report CAT I CCIRs by voice report to the NLSC POC. Initial voice reports will be followed by an e-mail within 12 hours. The need for a timely report will outweigh the desire for complete information. Follow-up e-mail reports are expected as new relevant facts emerge.

(2) Format. The e-mail distribution should include CNLSC in addition to those individuals identified in paragraph 3. For the CCIR voice report template, see enclosure (2). For the CCIR e-mail report template, see enclosure (3).

b. CAT II. Those incidents in which CNLSC and the Judge Advocate General (JAG) have an immediate interest but which do not rise to the level of SECNAV or CNO interest. For the NLSC CAT II reporting matrix, see enclosure (1).

(1) Timeline. Chief, VLCP, COs, or Executive Officers (XOs) will provide a timely report by e-mail. The need for a timely report will outweigh the desire for complete information. These reports should be made within 12 hours of the command becoming aware of the incident. Follow-up reports with additional new information should be expected at normal intervals as the situation develops.

(2) Format. The e-mail distribution should include those individuals identified in paragraph 3. Amplifying information should include a summary of the event as understood to date, past and ongoing action, and impact to mission. It is expected and understood that information may be incomplete. For the CCIR e-mail report template, see enclosure (3). For those circumstances that impact all NLSC commands equally, such as an imminent natural disaster, a single report can be coordinated between the RLSO, DSO, and VLCP.

c. CAT III. Those incidents in which CNLSC has an organizational interest due to potential impact on mission or resourcing availability but which do not require an immediate report. For the NLSC CAT III reporting matrix, see enclosure (1).


(1) Timeline. Routine e-mail reports should be provided within 48 hours by Chief, VLCP or the respective CO or XO as applicable.

(2) Format. The e-mail distribution should include those individuals identified in paragraph.

7. The need for complete information will be balanced with timeliness of the report. Amplifying information should include a summary of the event, ongoing action and impact to mission. For the format of the CCIR report, use routine and regular reporting mechanisms such as e-mail or TEAMS.

8. Records Management. Records created as a result of this instruction, regardless of media or format, shall be maintained and disposed of per records disposition schedules located on the DON Assistant for Administration (DONAA), Directives and Records Management Division portal page at: <https://portal.secnav.navy.mil/orgs/DUSNM/DONAA/DRM/Records-and-Information-Management/Approved%20Record%20Schedules/Forms/AllItems.aspx>.

9. Review and Effective Date. Per OPNAVINST 5215.17A, NLSC Executive Assistant will review this instruction annually around the anniversary of its issuance date to ensure applicability, currency and consistency with Federal, Department of Defense, Secretary of the Navy and Navy policy and statutory authority using OPNAV 5215/40 Review of Instruction. This instruction will be in effect for 10 years, unless revised or cancelled in the interim and will be reissued by the 10-year anniversary date if it is still required, unless it meets one of the exceptions in OPNAVINST 5215.17A, paragraph 9. Otherwise, if the instruction is no longer required, it will be processed for cancellation as soon as the need for cancellation is known following the guidance in OPNAV Manual 5215.1 of 2 2016.

SAMPLE CCIR CAT II-4 Update -

Subject: UPDATE #4: NLSC CCIR CAT II-4 - Notice of Imminent Natural Disasters

EA,

BLUF: IDALIA forecast track after landfall has moved slightly north after it makes the turn, resulting in minor improvement in projected impact for the tri-base. See chart below.

Details:


- All three installations still at 99% chance of sustained tropical storm-force winds (>33Kt).
 - Kings Bay has ~ 46% chance of sustained destructive force winds (>50KT).
 - JAX and MAY ~ 20% chance of sustained 50KT or greater.
 - Sustained gusts 25-40KT projected for tri-base until 2000 ET.
 - Safe and thorough damage assessment may not be possible until first light tomorrow but local conditions will determine.
 - Local counties are under a Tornado watch until at least 1500 ET.
- All tri-base RLSO SE, VLC, OSTC, C67, and Trial Judiciary personnel have mustered this morning and are sheltering-in-place.
 - Still NO personnel/families under mandatory evacuation orders or voluntary evacuation orders and desiring relocation.
 - Personnel advised on post-storm mustering, maintaining comms for post-storm directions, and post-storm dangers.
- Key West and Pensacola/Whiting Field to return to COR 5 by 1800 ET.
- No change to mission impact.
- No support or additional assistance is requested at this time.
