




Plea: Not Guilty; Disposition: Withdrawn and dismissed without prejudice.

SPECIFICATION 2 (Assault by strangulation): In that MK3 Joshua Woods, did, at or near Jacksonville, Florida, between on or about March 2020 to on or about June 2020, commit an assault upon [REDACTED] the spouse of the accused, by unlawfully strangling her by applying pressure to [REDACTED] neck with his forearm. Plea: Not Guilty; Disposition: Withdrawn and dismissed without prejudice.

SPECIFICATION 3 (Violent offense): In that MK3 Joshua Woods, did, at or near Jacksonville, Florida, on or about 24 June 2020, commit a violent offense against [REDACTED] the spouse of the accused, to wit: unlawfully push [REDACTED] head into the dashboard of a vehicle with his hands. Plea: Not Guilty; Disposition: Withdrawn and dismissed without prejudice.

SPECIFICATION 4 (Violent offense): In that MK3 Joshua Woods, did, at or near Jacksonville, Florida, on or about July 2020, commit a violent offense against [REDACTED] the spouse of the accused, to wit: unlawfully push [REDACTED] on the upper body with his arm. Plea: Not Guilty; Disposition: Withdrawn and dismissed without prejudice.

ADDITIONAL CHARGE: Violation of the UCMJ, Article 128 (Assault Consummated by a Battery)

Specification: In that MK3 Joshua Woods, did, on board [REDACTED] on or about March 2022, unlawfully touch IS3 [REDACTED] on the upper leg with MK3 Woods' hand, without IS3 [REDACTED] consent. Plea: Guilty; Finding: Guilty.
